Additional Information:

1. Each district association can send a maximum number of gymnasts as mentioned above on District Association letterhead duly signed by the authorised person.
2. All the gymnasts participating in the selection trials must submit self-attested valid age proof certificate and Aadhar copy. No gymnasts shall be allowed to participate without proper age certificate.
3. Each gymnast has to pay Rs. 250/- for entry fees for the selection trials.
4. Merit ranking in each discipline will be declared. The final team will be announced by MAGA. MAGA decision in this regard will be treated as final.
5. Code of Conduct in FOP: Each participant is advised to maintain a professional behaviour in FOP. MAGA strictly prohibits the use, possession, or consumption of alcohol in FOP.
6. The competition shall be conducted as per GFI age group program manual with latest FIG code of points. The Technical Chairman of respective discipline will have the power to clarify or provide for any doubts or difficulty.

7. Protest, if any, should be lodged with the Superior Jury with a fee of Rs. 500/-. The Protest must be submitted as per FIG Rules and on the letter head of the respective district/unit and should be signed by an authorized signatory.
8. All the entries should be forwarded to MAGA office by E-mail till **24th October 2024** by 6 PM on maha.gymnastics@gmail.com
